On December 21, 2006, Sociedad de Inversiones Pampa Calichera S.A. and Kowa Company Ltd. signed a "Joint Performance Agreement" essentially in relation to (a) the manner in which shares of SQM S.A. are voted in Shareholders' Meeting and (b) the eventual joint sale of said shares. The "Joint Performance Agreement" was modified on April 3, 2008 in order to further detail points related to the above letter (a).
